Tuition assistance scholarships are available to students with financial needs, as demonstrated by the student or parent's most recent federal income tax form, and with consideration of any unforeseen financial circumstances. This program is funded by our annual Rose Sale and Una Notte Bella events.

Awards:

- Vary in amount based on a financial sliding scale. Last year over \$45,000 was awarded.
- The amount awarded is applied for both fall and spring semester.
- Grants will be deducted from the total tuition charges.
- Awards are given out based on each student and are not transferable to another family member.
- Many of our students also receive scholarships from their schools or are supported by grandparents or other family members.

How to Apply:

- Complete both the financial information and student information.
- Attach a copy of ONLY the first page of your most recent federal income tax forms (1040, 1040A, 1040EZ). Please black out any social security numbers listed.
 - **Please note: if income tax form does not accompany this application, it will not be accepted.**
- All information will be kept strictly confidential, and federal forms will be shredded after application is processed. Awards amounts are not shared with faculty.
- Applications from students with a past due balance will not be considered until the balance is paid in full.

Expectations:

- Student and/or parent will be required to volunteer small amounts of time throughout the year (Rose Sale, Una Notte Bella, Christmas Cabaret Concert, moving tables and chairs, etc.).
- Student is expected to attend all lessons/classes/ensembles.
- Student is required to bring appropriate materials (i.e. instrument and music).
- Recipient must meet established deadlines for tuition payment.
